Molin Concrete worked with Kraemer Brothers of Plain, WI on the Villas of the Wisconsin Dells. This six-story structure relied heavily on hollow core provided by Molin, which was set on CMU bearing walls. Phase II, which Molin worked on, cost over \$12 Million and will add 54 condominiums to the current project. The building will use over 5,000 tons of precast concrete products and more than 100,000 concrete blocks.

Early on, the GC requested a very short delivery time, which Molin was able to meet. In addition to the hollow core, the Villas of Wisconsin Dells features 45 rounded precast decks that Molin supplied. These decks were cast in our precast shop using mild steel reinforcement. The decks included cast-in embeds that allow railings to be attached. The project will be finished in early 2007.
